AUTHORIZATION TO EXECUTE A CONTRACT WITH FEIGUS OFFICE FURNITURE TO REUPHOLSTER THE MAIN MEETING ROOM SEATING TO A SANITARY WIPEABLE SURFACE THROUGH THE MIDDLESEX REGIONAL EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY AT A PRICE NOT TO EXCEED \$46,477.90

WHEREAS, the Township of Wall entered into the Middlesex Regional Educational Services Commission of New Jersey on March 12, 2014; and

WHEREAS, the Township Committee wants to reupholster the main meeting room seats to a sanitary wipeable surface; and

WHEREAS, the Administrator received a proposal from Feigus Furniture through the Middlesex Regional Educational Services Commission of New Jersey; and

WHEREAS, the Township Administrator has reviewed the request for the main meeting room and approves the request; and

WHEREAS, the Chief Financial Officer of the Township has certified that the funds are available to retain and enter into a contract with Feigus Office Furniture to reupholster the main meeting room seating to a sanitary wipeable surface in the amount not to exceed \$46,477.90 (forty-six thousand four hundred seventy-seven dollars and ninety cents).

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Wall, County of Monmouth, New Jersey that the Township award the contract to Feigus Office Furniture to reupholster the seats in the main meeting room in the total not to exceed amount of \$46,477.90 (forty-six thousand four hundred seventy-seven dollars and ninety cents).

BE IT FURTHER RESOLVED, that all Township officials including, but not limited to the Mayor, the Township Administrator and the Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the provisions of this Resolution.


