RESOLUTION NO. 19-0221

AUTHORIZATION TO EXECUTE A CONTRACT WITH BREAKER ELECTRIC, INC. FOR ELECTRIC SERVICE AT CAMP EVANS DIANA SITE AT A PRICE NOT TO EXCEED \$59,000.00

WHEREAS, pursuant to N.J.S.A. 40A:11-5 et seq., the Local Public Contract Law, the Township Committee previously authorized the advertisement for the receipt of bids for electric service at the Camp Evans Diana Site; and

WHEREAS, on Friday, February 22, 2019 the Township received five (5) proposals; the top three (3) lowest responsive base bids are identified as follows:


WHEREAS, Matthew Zahorsky, Township Engineer, for the Township of Wall, recommended to the Township Committee the contract be awarded to Breaker Electric, Inc.; and

WHEREAS, the Township Attorney reviewed the bid of Breaker Electric, Inc. and found same to be legally sufficient; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs in the recommendation of Matthew Zahorsky, Township Engineer for the Township of Wall and hereby awards the contract for electric service at Camp Evans Diana Site to Breaker Electric, Inc. at a price not to exceed \$59,000.00 (fifty-nine thousand dollars).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C. 5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
