RESOLUTION NO. 19-0407

AUTHORIZING THE ADOPTION OF THE 2019 MUNICIPAL BUDGET FOR THE TOWNSHIP OF WALL

WHEREAS, the local Municipal budget for the year 2018 was approved by Resolution No. 19-0307 on March 27, 2019; and

WHEREAS, the public hearing on said budget has been held as advertised in the April 4, 2019 edition of the Coast Star; and

BE IT RESOLVED, by the Township Committee of the Township of Wall that the following statements of revenues and appropriations shall constitute the Municipal Budget of the Township of Wall, County of Monmouth for the Fiscal Year 2019;

GENERAL APPROPRIATIONS:

- 1. Appropriations within "CAPS" \$33,379,139.45
2. Appropriations excluded from "CAPS" 5,384,532.81
3. Reserve for Uncollected Taxes (Item M, Sheet 29) -Based on Estimated 97.63 Percent of Tax Collections 2,772,947.18
4. Total General Appropriations (Item 9, Sheet 29) 41,536,619.44
5. Less: Anticipated Revenues Other than Current Property Tax (Item 5, Sheet 11) (i.e. Surplus, Miscellaneous Revenues and Receipts from Delinquent Taxes) 13,860,778.75
6. Difference: Amount to be raised by Taxes for support of Municipal Budget: (as follows) (a) Local Tax for Municipal Purposes including Reserve for Uncollected Taxes (Item 6(a), Sheet 11) 27,675,840.69
