

**TOWNSHIP OF WALL**

**RESOLUTION NO. 19-0413**

**AUTHORIZATION TO RENEW THE SERVICE CONTRACT WITH TRANE BUILDING ADVANTAGE FOR HVAC EQUIPMENT AT THE DEPARTMENT OF PUBLIC WORKS, THE MUNICIPAL BUILDING, LIBRARY, POLICE DEPARTMENT AND YOUTH CENTER AT A PRICE NOT TO EXCEED \$44,133.00**

**WHEREAS**, the Township Committee is desirous of renewing a service agreement with Trane Building Advantage through US Communities Cooperative Purchasing Program #15-JLP-023; and

**WHEREAS**, the HVAC service contract being recommended for the Department of Public Works, the Municipal Building, Library, the Police Department and the Youth Center is under cooperative purchasing through US Communities Cooperative Purchasing Program # 15-JLP-023 at a price not to exceed \$44,133.00 (forty-four thousand one hundred thirty-three dollars); and

**WHEREAS**, Joseph Lentini, Director of Public Works, recommends that the Township Committee renew the service contract under cooperative purchasing; and

**WHEREAS**, the Township Administrator concurs with the recommendation to renew this service agreement through US Communities Cooperative Purchasing Program # 15-JLP-023 at a price not to exceed \$44,133.00 (forty-four thousand one hundred thirty-three dollars); and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Joseph Lentini, Director of Public Works to authorize the renewal of the service contract for HVAC services through US Communities Cooperative Purchasing Program # 15-JLP-023 at a price not to exceed \$44,133.00 (forty-four thousand one hundred thirty-three dollars).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
