RESOLUTION NO. 19-0503

AUTHORIZING THE TOWNSHIP OF WALL TO AWARD A CONTRACT TO AMUSEMENTS OF AMERICA FOR THE FURNISHING AND DELIVERY OF AMUSEMENTS, FOOD VENDORS AND GAMES FOR THE YEAR 2019 WALL TOWNSHIP FAIR

WHEREAS, the Township of Wall advertised and solicited bids for the furnishing and delivery of amusements, food vendors and games for the year 2019 for the 2019 Wall Township Fair to be held June 27, 2019 through June 30, 2019 at Wall Township Municipal Complex; and

WHEREAS, the Township of Wall received a single bid from Amusements of America, located at 24 Federal Road, Monroe Township, NJ 08831 to provide these services to the Township; and

WHEREAS, Amusements of America has proposed paying the Township of Wall 30% of ticket proceeds up to \$175,000.00 ride gross amusement ticket sales after taxes and 10% commission for the mega-band passes; and


WHEREAS, Amusements of America has proposed paying the Township of Wall \$25.00 (twenty-five dollars) for each amusement game and \$350.00 (three hundred fifty) for each food vendor and proposes providing six (6) food vendors and five (5) amusement games for the Wall Township Fair; and

WHEREAS, the Wall Township Director of Recreation, Elizabeth Cellini, has evaluated the proposal for qualifications, experience and cost reasonableness, and recommends the award of the contract to Amusements of America; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Wall, County of Monmouth, New Jersey that the Township award the contract for the furnishing and delivery of amusements, food vendors and games for the 2019 Wall Township Fair.

BE IT FURTHER RESOLVED, that all Township officials including, but not limited to the Mayor, the Township Administrator and the Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the provisions of this resolution.
