

TOWNSHIP OF WALL
RESOLUTION NO. 19-0832

**AUTHORIZING WALL TOWNSHIP TO AWARD BID FOR REPAVING OF
VARIOUS ROADS LOCATED IN WALL TOWNSHIP TO MECO
INCORPORATED IN AN AMOUNT NOT TO EXCEED \$1,344,804.00**

WHEREAS, the Township of Wall published requests for bids pursuant to N.J.S.A 40A:11-1 et seq. for repaving of various roads located within the Township of Wall; and,

WHEREAS, the Township on July 19, 2019 the township received five (5) bids, the top three (3) lowest responsive bidders are identified as follows:

BIDDER	BASE BID PLUS BID ALTERNATES
MECO, Inc.	\$1,344,804.00 (one million three hundred forty-four thousand eight hundred and four dollars and zero cents)
Earle Asphalt Co.	\$1,497,613.13 (one million four hundred ninety-seven thousand six hundred and thirteen dollars and thirteen cents)
Esposito Construction	\$1,592,992.50 (one million five hundred and ninety-two thousand nine hundred and ninety-two dollars and fifty cents)

WHEREAS, the Township Engineer, Matthew Zahorsky reviewed all of the bids and issued a Recommendation of Award to Meco Incorporated; and,


WHEREAS, Meco Incorporated was the lowest responsive bidder at a combined bid for the base bid amount plus the bid alternates number one through five for a total award amount of \$1,344,804.00 (one million three hundred forty-four thousand eight hundred and four dollars and zero cents); and,

WHEREAS, the Municipal Attorney reviewed the bid submitted by Meco Incorporated and determined that the bid was legally sufficient; and,

NOW, THEREFORE, BE IT RESOLVED, by the Wall Township Committee, as follows:

1. The Township of Wall hereby authorizes the Township Administrator, Engineer and Administrative staff to take whatever ministerial actions are necessary to effectuate the terms of this Resolution; and,
2. This Resolution shall take effect immediately.


