RESOLUTION NO. 19-0926

**AUTHORIZING WALL TOWNSHIP TO AWARD BID FOR THE RETAINING WALL CONSTRUCTION AT THE DEPARTMENT OF PUBLIC WORKS RECYCLING FACILITY TO ALBERT MARINE CONSTRUCTION IN AN AMOUNT NOT TO EXCEED \$69,069.00**

**WHEREAS**, the Township of Wall published requests for bids pursuant to N.J.S.A 40A:11-1 et seq. for the retaining wall construction at the Department of Public Works recycling facility; and,

**WHEREAS**, the Township on September 20, 2019 the town received six (6) bids, the top three (3) lowest responsive bidders are identified as follows:

<b>BIDDER</b>	<b>BASE BID</b>
Albert Marine Construction	\$69,069.00 (sixty-nine thousand sixty-nine and zero cents)
TR Weniger, Inc.	\$70,000.00 (seventy thousand and zero cents)
V&K Construction, Inc.	\$94,500.00 (ninety-four thousand five hundred and zero cents)

**WHEREAS**, the Township Engineer, Matthew Zahorsky reviewed all of the bids and issued a Recommendation of Award to Albert Marine Construction; and,


**WHEREAS**, Albert Marine Construction was the lowest responsive bidder at a base bid amount of \$69,069.00 (sixty-nine thousand sixty-nine and zero cents); and,

**WHEREAS**, the Municipal Attorney reviewed the bid submitted by Albert Marine Construction and determined that the bid was legally sufficient; and,

**NOW, THEREFORE, BE IT RESOLVED**, by the Wall Township Committee, as follows:

1. The Township of Wall hereby authorizes the Township Administrator, Engineer and Administrative staff to take whatever ministerial actions are necessary to effectuate the terms of this Resolution; and,
2. This Resolution shall take effect immediately.
