**AUTHORIZATION TO EXECUTE A CONTRACT WITH WATCHGUARD TO PURCHASE 8 (EIGHT) BODY WORN CAMERAS AND OPTIONS WITH WARRANTIES, LICENSING AND TECHNICAL SERVICES THROUGH STATE CONTRACT NUMBER T0106 AT A COST NOT TO EXCEED \$24,698.00**

**WHEREAS**, the Wall Township Police Department has determined that it is necessary to purchase 8 (eight) body worn cameras and options with warranties, licensing, and technical services; and,

**WHEREAS**, Wall Township recognizes the importance of the purchase of the body worn cameras which is required to assist the Police Department in all aspects of its role as community caretaker and law enforcement agency; and,

**WHEREAS**, Wall Township received a proposal from WATCHGUARD to purchase the 8 (eight) body worn cameras and options with warranties, licensing, and technical services through State Contract Number T0106 at a cost not to exceed \$24, 698.00 (twenty-four thousand six hundred ninety-(eight) dollars and zero cents) and the Wall Township CFO and Police Chief have agreed that this proposal is reasonable and cost effective; and,

**NOW, THEREFORE, BE IT RESOLVED**, the Wall Township Mayor is hereby authorized to execute an agreement with WATCHGUARD in the amount of \$24,698.00 (twenty-four thousand six hundred ninety- eight dollars and zero cents) for the 8 (eight) body worn cameras; and,

**BE IT FURTHER RESOLVED**, that all Township officials including, but not limited to the Mayor, the Township Administrator and the Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the provisions of this resolution.
