RESOLUTION NO. 18-0214

AUTHORIZATION TO EXECUTE A CONTRACT WITH MALL CHEVROLET 75 FOR THE PURCHASE A CHEVROLET TAHOE THROUGH THE EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY (ESCNJ) AT A PRICE NOT TO EXCEED \$36,590.00

WHEREAS, the Township Committee is desirous of purchasing a Chevrolet Tahoe from Mall Chevrolet 75 through the Educational Services Commission of New Jersey; and

WHEREAS, the Chevrolet Tahoe being purchased is under the Educational Services Commission of New Jersey from Mall Chevrolet 75 at a price not to exceed \$36,590.00 (thirty-six thousand five hundred ninety dollars); and

WHEREAS, Kenneth Brown, Jr., Chief of Police, recommends that the Township Committee purchase the Chevrolet Tahoe under cooperative purchasing; and


WHEREAS, the Township Administrator concurs with the recommendation to purchase the Chevrolet Tahoe through the Educational Services Commission of New Jersey at a price not to exceed \$36,590.00 (thirty-six thousand five hundred ninety dollars).

WHEREAS, the Township of Wall entered into the Educational Services Commission of New Jersey on March 12, 2014; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Kenneth Brown, Jr., Chief of Police, to authorize the purchase of the following: One (1) Chevrolet Tahoe under the Educational Services Commission of New Jersey from Mall Chevrolet 75 at a price not to exceed \$36,590.00 (thirty-six thousand five hundred ninety dollars).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
