**AUTHORIZATION TO EXECUTE A CONTRACT WITH CUSTOM
CONCRETE FOR THE REMOVAL AND REPLACEMENT OF SIDEWALKS
AND CURBS AT TOWN HALL AND THE LIBRARY THROUGH STATE
CONTRACT T0278 AT A PRICE NOT TO EXCEED \$49,438.20**

WHEREAS, the Township of Wall wishes to remove and replace sidewalks and curbs at Town Hall and the Library and;

WHEREAS, the removal and replacement service being recommended for purchase under State Contract #T0278 is being provided by Custom Concrete; and


WHEREAS, the Director of Public Works of the Township of Wall recommends the utilization of State Contract on the grounds that they can provide the quality of products at the most reasonable price; and

WHEREAS, the Township Committee acknowledges that sufficient funds exist for the purpose of this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Wall, County of Monmouth, State of New Jersey that the removal and replacement of sidewalks and curbs at Town Hall and the Library recommended for the purchase under State Contract #T0278 are from Custom Concrete at a price not to exceed \$49,438.20 (forty-nine thousand four hundred thirty-eight dollars and twenty cents) is hereby ratified.

BE IT FURTHER RESOLVED that all Township officials including, but not limited to, the Mayor, Chief of Police and the Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the provisions of this resolution.


