**AUTHORIZATION TO EXECUTE A CONTRACT WITH A.C. SCHULTES, INC.
FOR THE ALLENWOOD WELLS NO. 10 AND 11 PROJECT IN THE AMOUNT
OF \$2,191,000.00**

WHEREAS, pursuant to N.J.S.A. 40A:11-5 et seq., the Local Public Contract Law, the Township Committee previously authorized the advertisement for the receipt of bids for the Allenwood Wells No. 10 and 11 project; and

WHEREAS, on January 19, 2018 the Township received one (1) bid proposal, which are identified as follows:

1. A.C. Schultes, Inc. \$2,191,000.00 (two million one hundred ninety-one thousand dollars)

WHEREAS, Matthew Zahorsky the Township Engineer, recommended to the Township Committee the contract be awarded to A.C. Schultes, Inc.; and

WHEREAS, the Township Attorney reviewed the bid of A.C. Schultes, Inc. and found same to be legally sufficient; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs in the recommendation Matthew Zahorsky the Township Engineer and hereby awards the contract for Allenwood Wells No. 10 and 11 project to A.C. Schultes, Inc.
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C. 5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
