**AUTHORIZATION TO EXECUTE A CONTRACT WITH BREAKER ELECTRIC, INC. FOR MUNICIPAL AND POLICE DEPARTMENT EMERGENCY GENERATORS AT A CONTRACT PRICE OF \$860,400.00 PER YEAR**

**WHEREAS**, pursuant to N.J.S.A. 40A:11-5 et seq., the Local Public Contract Law, the Township Committee previously authorized the advertisement for the receipt of bids for Municipal and Police Department Emergency Generators; and

**WHEREAS**, on Friday, March 23, 2018 the Township received three (3) bid proposals, which are identified as follows:



**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs in the recommendation Matthew Zahorsky, Township Engineer and hereby awards the contract for Municipal and Police Department Emergency Generators to Breaker Electric Inc. in an amount not to exceed \$860,400.00 (eight hundred sixty thousand four hundred dollars).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C. 5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
