RESOLUTION NO. 18-0713

AUTHORIZING THE TOWNSHIP OF WALL TO EXECUTE A CONTRACT WITH FOLEY INC. FOR THE PURCHASE OF ONE (1) CATERPILLAR MODEL 950GC WHEEL LOADER THROUGH THE NATIONAL JOINT POWERS ALLIANCE (NJPA) COOPERATIVE PURCHASING PROGRAM AT A PRICE NOT TO EXCEED \$217,161.78

WHEREAS, the Township of Wall Committee is desirous of purchasing a Caterpillar Model 950GC wheel loader from Foley Inc. through the National Joint Powers Alliance (NJPA); and,

WHEREAS, the Caterpillar Model 950GC wheel loader being recommended for purchase is through the National Powers Alliance (NJPA) at a price not to exceed \$217,161.78 (two hundred seventeen thousand one hundred sixty-one dollars and seventy-eight cents); and

WHEREAS, Joseph Lentini, Director of Public Works, recommends that the Township Committee purchase the Caterpillar Model 950GC wheel loader from Foley Inc. through the NJPA; and


WHEREAS, the Township Administrator concurs with the recommendation to purchase of the Caterpillar Model 950GC wheel loader through NJPA at a price not to exceed \$217,161.78 (two hundred seventeen thousand one hundred sixty-one dollars and seventy-eight cents); and

WHEREAS, the Township of Wall entered into the National Purchasing Program on July 28, 2016; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Joseph Lentini, Director of Public Works to authorize the purchase of the Caterpillar Model 950GC from Foley Inc. through the NJPA at a price not to exceed \$217,161.78 (two hundred seventeen thousand one hundred sixty-one dollars and seventy-eight cents).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
