RESOLUTION NO. 18-0716

AUTHORIZATION TO EXECUTE A CONTRACT WITH CHERRY VALLEY TRACTOR FOR THE PURCHASE A KUBOTA RTVX900WL-H THROUGH THE EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY (ESCNJ) AT A PRICE NOT TO EXCEED \$16,493.15

WHEREAS, the Township Committee is desirous of purchasing a Kubota RTVX900WL-H from Cherry Valley Tractor Sales through the Educational Services Commission of New Jersey; and

WHEREAS, the Kubota RTVX900WL-H recommended for purchase under the Educational Services Commission of New Jersey from Cherry Valley Tractor shall not exceed a price of \$16,493.15 (sixteen thousand four hundred ninety-three dollars and fifteen cents); and

WHEREAS, Joseph Lentini, Director of Public Works, recommends that the Township Committee purchase the Kubota RTVX900WL-H under cooperative purchasing; and


WHEREAS, the Township Administrator concurs with the recommendation to purchase the Kubota RTVX900WL-H through Educational Services Commission of New Jersey at a price not to exceed \$16,493.15 (sixteen thousand four hundred ninety-three dollars and fifteen cents); and

WHEREAS, the Township of Wall entered into the Educational Services Commission of New Jersey on March 12, 2014; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Joseph Lentini, Director of Public Works to authorize the purchase of a Kubota RTVX900WL-H under the Educational Services Commission of New Jersey from Cherry Valley Tractor at a price not to exceed \$16,493.15 (sixteen thousand four hundred ninety-three dollars and fifteen cents).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
