AUTHORIZATION TO EXECUTE A CONTRACT WITH OMAHA STANDARD, LLC FOR THE PURCHASE OF SIX (6) 40-YARD CONTAINERS WITH COMBINATION LIFT SYSTEMS THROUGH THE SOMERSET COOPERATIVE PURCHASING SYSTEM #2SOCCP AT A PRICE NOT TO EXCEED \$40,362.00

WHEREAS, the Township Committee is desirous of purchasing six (6) 40-yard containers with a combination lift system from Omaha Standard, LLC through the Somerset Cooperative Purchasing System #2SOCCP; and

WHEREAS, the 40-yard containers being recommended for purchase under the Somerset Cooperative Purchasing System include six (6) 40-yard containers with combination lift systems from Omaha Standard, LLC at a price not to exceed \$40,362.00 (forty thousand three hundred sixty-two dollars); and

WHEREAS, Joseph Lentini, Director of Public Works, recommends that the Township Committee purchase the 40-yard containers under cooperative purchasing; and

WHEREAS, the Township Administrator concurs with the recommendation to purchase the 40-yard containers through Somerset Cooperative Purchasing System at a price not to exceed \$40,362.00 (forty thousand three hundred sixty-two dollars); and

WHEREAS, the Township of Wall entered into the Somerset Cooperative Purchasing System on December 23, 2014; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Joseph Lentini, Director of Public Works to authorize the purchasing six (6) 40-yard containers with a combination lift system from Omaha Standard, LLC through the Somerset Cooperative Purchasing System #2SOCCP at a price not to exceed \$40,362.00 (forty thousand three hundred sixty-two dollars).

4. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
