**AUTHORIZATION TO EXECUTE A CONTRACT WITH PILOT ELECTRIC FOR THE PURCHASE OF WASTEWATER PUMP STATION SEWER PUMPS THROUGH THE NORTH JERSEY WASTEWATER COOPERATIVE PRICING SYSTEM AT A PRICE NOT TO EXCEED \$101,736.35**

**WHEREAS**, the Township Committee is desirous of purchasing wastewater pump station sewer pumps from Pilot Electric through the North Jersey Wastewater Cooperative Pricing System; and

**WHEREAS**, the wastewater pump station sewer pumps being recommended for purchase is under the North Jersey Wastewater Cooperative Pricing System from Pilot Electric. at a price not to exceed \$101,736.35 (one hundred one thousand seven hundred thirty-six dollars and thirty-five cents); and

**WHEREAS**, Joseph Lentini, Director of Public Works, recommends that the Township Committee purchase the wastewater pump station sewer pumps under cooperative purchasing; and


**WHEREAS**, the Township Administrator concurs with the recommendation to purchase the wastewater pump station sewer pumps through the North Jersey Wastewater Cooperative Pricing System at a price not to exceed \$101,736.35 (one hundred one thousand seven hundred thirty-six dollars and thirty-five cents); and

**WHEREAS**, the Township of Wall entered into the North Jersey Wastewater Cooperative Pricing System on October 26, 2016.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Joseph Lentini, Director of Public Works, to authorize the purchase of the following wastewater pump station sewer pumps being recommended for purchase is under the North Jersey Wastewater Cooperative Pricing System from Pilot Electric. at a price not to exceed \$101,736.35 (one hundred one thousand seven hundred thirty-six dollars and thirty-five cents).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
