**AUTHORIZING THE TOWNSHIP OF WALL TO ENTER INTO A CONTRACT
WITH UNITED CLEANING CONTRACTORS TO PROVIDE JANITORIAL
SERVICES TO WALL TOWNSHIP**

WHEREAS, pursuant to N.J.S.A. 40A:11-1 et. Seq. the Township of Wall advertised to solicit bids for janitorial services for the Township's municipal buildings; and,

WHEREAS, Wall Township received two bids on June 6, 2018 at which time said bids were unsealed; and,

WHEREAS, the low bid was submitted by Best Building Service, Inc. 1121 Edgewater Avenue, Ridgefield, NJ 07657; and,

WHEREAS, on September 12, 2018, Best Building Service, Inc. informed the Township of Wall that it requested its bid be withdrawn based on the fact that it had made an error in the amount of the bid; and,


WHEREAS, Wall Township has contacted the second bidder, United Cleaning Contractors, who have agreed to undertake janitorial services for the Township at the same rate and pursuant to the proposal they submitted in their June 6, 2018 bid; and

WHEREAS, the Wall Township Mayor and Committee desire to retain the services of United Cleaning Contractors at a rate of \$128,940.00 per year commencing October 1, 2018; and,

NOW, THEREFORE, BE IT RESOLVED, that the Wall Township Mayor and Township Committee are hereby authorized to enter into an agreement with United Cleaning Contractors for janitorial services; and,

BE IT FURTHER RESOLVED, that all Township officials including, but not limited to the Mayor, the Township Administrator and the Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the provisions of this resolution.


Certification of Funds
