

**TOWNSHIP OF WALL**

**RESOLUTION NO. 18-1104**

**AUTHORIZING WALL TOWNSHIP TO AWARD BID FOR REPAVING OF  
VARIOUS ROADS LOCATED IN WALL TOWNSHIP TO MECO  
INCORPORATED IN AN AMOUNT NOT TO EXCEED \$1,532,785.30**

**WHEREAS**, the Township of Wall published requests for bids pursuant to N.J.S.A 40A:11-1 et seq. for repaving of various roads located within the Township of Wall; and,

**WHEREAS**, the Township on November 2, 2018 received nine (9) bids, the top three (3) lowest responsive bidders as identified as follows:

<b>BIDDER</b>	<b>BASE BID PLUS BID ALTERNATES</b>
MECO, Inc.	\$1,532,785.30 (one million five hundred and thirty two thousand seven hundred and eighty five dollars and thirty cents)
P&A Construction, Inc.	\$1,571,837.45 (one million five hundred and seventy one thousand eight hundred and thirty seven dollars and forty five cents)
Earle Asphalt Co.	\$1,584,613.13 (one million five hundred and eighty four thousand six hundred and thirteen dollars and thirteen cents)

**WHEREAS**, the Township Engineer, Matthew Zahorsky reviewed all of the bids and issued a Recommendation of Award to Mecco Incorporated; and,


**WHEREAS**, Mecco Incorporated was the lowest responsive bidder at a combined bid for the base bid amount plus the bid alternates number one through three and bid alternates five through seven for a total award amount of \$1,532,785.30 (one million five hundred and thirty two thousand seven hundred and eighty five dollars and thirty cents); and,

**WHEREAS**, the Municipal Attorney reviewed the bid submitted by Mecco Incorporated and determined that the bid was legally sufficient; and,

**NOW, THEREFORE, BE IT RESOLVED**, by the Wall Township Committee, as follows:

1. The Township of Wall hereby authorizes the Township Administrator, Engineer and Administrative staff to take whatever ministerial actions are necessary to effectuate the terms of this Resolution; and,
2. This Resolution shall take effect immediately.
