

TOWNSHIP OF WALL

RESOLUTION NO. 18-1220

AUTHORIZING THE TOWNSHIP OF WALL TO PROVIDE NOTICE OF INTENTION TO PURCHASE A STEPP MFG. OJK-V VERTICAL CRACK SEALER FROM TIMMERMAN EQUIPMENT CO. THROUGH THE NATIONAL COOPERATIVE PURCHASING ALLIANCE, AN AMOUNT NOT TO EXCEED \$45,040.00

WHEREAS, Pursuant to N.J.S.A. 52:34-6 et seq. Wall Township has engaged in a price comparison with various vendors and has determined that a cost savings would occur if Wall Township purchased a Stepp Mfg. OJK-V Vertical Crack Sealer the National Cooperative Purchasing Alliance (NCPA), a national cooperative and Wall Township has confirmed that NCPA satisfies the definition of a National Cooperative pursuant to N.J.S.A. 52:34-6 et seq.; and,


WHEREAS, Wall Township authorizes publication of its intent to purchase a Stepp Mfg. OJK-V Vertical Crack Sealer from Timmerman Equipment Co. through NCPA; and,

WHEREAS, Wall Township understands that if no comments are made to the Township during a ten-day period after said publication that it intends to purchase one (1) a Stepp Mfg. OJK-V Vertical Crack Sealer for a cost of \$45,040.00 (forty-five thousand forty dollars); and,

WHEREAS, the Township Committee acknowledges that sufficient funds exist for the purpose of this resolution.

NOW, THEREFORE, BE IT RESOLVED, that all Township officials including, but not limited to the Mayor, the Township Administrator and the Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the provisions of this resolution.
