**AUTHORIZATION TO EXECUTE A CONTRACT WITH DFFLM LLC T/A
DITSCHMAN/FLEMINGTON FORD TO PURCHASE A 2021 FORD F350 HIGH
ROOF EXTENDED CARGO VAN THROUGH STATE CONTRACT NO. A88211
AT A PRICE NOT TO EXCEED \$34,888.00**

WHEREAS, the Township Committee is desirous of contracting with DFFLM LLC ta/ Ditschman/Flemington Ford to purchase a F350 High Roof Extended Cargo Van for the Department of Public Works through State Contract No. A88211; and

WHEREAS, the contract to purchase F350 High Roof Extended Cargo Van from DFFLM LLC ta/ Ditschman/Flemington Ford for the Department of Public Works will be at a price not to exceed \$34,888.00 (thirty-four thousand eight hundred eighty-eight dollars and zero cents); and


WHEREAS, Joseph Lentini, Superintendent of the Department of Public Works, recommends that the Township Committee purchase the F350 High Roof Extended Cargo Van through State Contract; and

WHEREAS, the Township Administrator concurs with the recommendation to purchase the F350 High Roof Extended Cargo Van from DFFLM LLC ta/ Ditschman/Flemington Ford at a price not to exceed \$34,888.00 (thirty-four thousand eight hundred eighty-eight dollars and zero cents); and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Joseph Lentini, Superintendent of the Department of Public Works, to authorize the purchase of a F350 High Roof Extended Cargo Van from DFFLM LLC ta/ Ditschman/Flemington Ford at a price not to exceed \$34,888.00 (thirty-four thousand eight hundred eighty-eight dollars and zero cents)
2. This resolution is subject to the filing of a certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk, Township Administrator and any other appropriate Township officers or employees are hereby authorized and directed to sign the contract and to take such ministerial actions as are necessary to effectuate the terms of this resolution.


