RESOLUTION NO. 21-0813

AUTHORIZATION TO EXECUTE AN AGREEMENT WITH SONRAI SYSTEMS, LLC, FOR THE PURCHASE OF MODEMS, SIM CARDS AND ANTENNAS AT A PRICE NOT TO EXCEED \$10,915.00

WHEREAS, the Township of Wall previously advertised and solicited bids pursuant to N.J.S.A. 40A:11-1 et. seq. for RFID readers and associated tracking software and equipment for sanitation containers for use by the Department of Public Works; and

WHEREAS, the Township Administrator reviewed the bids submitted and found that Sonrai Systems was the lowest responsible and responsive bidder; and


WHEREAS, the Township previously executed a contract with Sonrai Systems, LLC for the purchase of RFID readers and associated tracking software and equipment for sanitation containers used by the Department of Public Works; and

WHEREAS, the Township Administrator recommends that the Township execute a contract with Sonrai Systems, LLC, in the amount of \$10,915.00 (ten thousand nine hundred fifteen dollars and zero cents) for the purchase of modems, sim cards, and antennas necessary to update the Township's current system; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of the Township Administrator, to authorize the purchase of modems, sim cards, and antennas necessary to update the Township's current system in an amount not to exceed \$10,915.00 (ten thousand nine hundred fifteen dollars and zero cents)
2. This resolution is subject to the filing of a certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
