**AUTHORIZATION TO EXECUTE A CONTRACT WITH ELITE VEHICLE FOR THE PURCHASE OF 5 (FIVE) MODULAR MOUNT COMPUTERS THROUGH STATE CONTRACT #T-0106 AT A PRICE NOT TO EXCEED \$29,318.55**

**WHEREAS**, the Township Committee wants to acquire 5 (five) modular mount computers for the Police Department; and

**WHEREAS**, the 5 (five) modular mount computers are being purchased through State Contract #T-0106 from Elite Vehicle at a price not to exceed \$29,318.55 (twenty-nine thousand three hundred eighteen dollars and fifty-five cents); and

**WHEREAS**, Kenneth Brown Jr., Chief of Police, recommends that the Township Committee purchase 5 (five) modular mount computers through State Contract; and

**WHEREAS**, the Township Administrator concurs with the recommendation to purchase 5 (five) modular mount computers through the State Contract #T-0106 at a price not to exceed \$29,318.55 (twenty-nine thousand three hundred eighteen dollars and fifty-five cents); and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Wall, County of Monmouth, New Jersey that the Township award the contract for 5 (five) modular mount computers from Elite Vehicle through State Contract #T-0106 for the Police Department in the total amount of \$29,318.55 (twenty-nine thousand three hundred eighteen dollars and fifty-five cents)
