AUTHORIZATION TO UTILIZE THE SERVICES OF SONNENFELD AND TROCCHIA ARCHITECTS, P.A. FOR PREPARATION OF DESIGN SERVICES, CONSTRUCTION DOCUMENT SERVICES, BID SPECIFICATIONS AND AUTHORIZATION TO PUBLICLY BID FOR THE REPLACEMENT OF THE STORM DAMAGED ROOF SYSTEMS AT CAMP EVANS

WHEREAS, pursuant to N.J.S.A. 40A: 11-5, Wall Township appointed Sonnenfeld and Trocchia Architects, P.A. as consulting architects for the 2021 calendar year; and;


WHEREAS, Wall Township desires to utilize the architectural services of Sonnenfeld and Trocchia Architects, P.A. for design services, construction document services, bid specifications and authorization to publicly bid for the replacement of the storm damaged roof systems at Camp Evans; and

WHEREAS, The Wall Township Business Administrator, Jeffry Bertrand, has reviewed the proposal submitted by Sonnenfeld and Trocchia Architects, P.A., and is of the opinion that the Township should authorize payment for design services, construction document services, bid specifications and assisting in the public bidding process located at the Township Municipal Complex in an amount not to exceed \$9,500 (nine thousand five hundred dollars) in addition as needed hourly construction administration services at a price not to exceed \$7,000 (seven thousand dollars) and

NOW, THEREFORE, BE IT RESOLVED, the Wall Township Mayor is hereby authorized to execute an agreement, approved by the Township Attorney, with Sonnenfeld and Trocchia Architects on behalf of Wall Township; and,

BE IT FURTHER RESOLVED, that all Township officials including, but not limited to the Mayor, the Township Administrator and the Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the provisions of this resolution.


