RESOLUTION NO. 22-0139

AUTHORIZATION TO EXECUTE A CONTRACT WITH VCI EMERGENCY VEHICLE SPECIALISTS FOR THE PURCHASE OF A FORD E450 AMBULANCE THROUGH THE HOUSTON GALVESTON COOPERATIVE PRICING PROGRAM AT A PRICE NOT TO EXCEED \$215,000.00

WHEREAS, the Township Committee is desirous of purchasing a Ford E450 Ambulance through the Houston Galveston Cooperative Pricing Program; and,

WHEREAS, the Ford E450 Ambulance being purchased are through the Houston Galveston Cooperative Pricing Program from VCI Emergency Vehicle Specialists at a price not to exceed \$215,000.00 (two hundred and fifteen thousand dollars and zero cents); and,

WHEREAS, John Spinapont, Superintendent of Public Works, recommends that the Township Committee purchase the Ford E450 Ambulance through cooperative purchasing; and,


WHEREAS, the Township Administrator and Township Committee concurs with the recommendation to purchase the Ford E450 Ambulance from VCI Emergency Vehicle Specialists through the Houston Galveston Cooperative Pricing Program at a price not to exceed \$215,000.00 (two hundred and fifteen thousand dollars and zero cents); and,

WHEREAS, the Township of Wall began to participate on May 28, 2014, in the cooperative purchasing program operated by the Houston Galveston Cooperative Pricing Program.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Mr. Spinapont, Superintendent of Public Works, to authorize the purchase of Ford E450 Ambulance carts being purchased are through the Houston Galveston Cooperative Pricing Program from VCI Emergency Vehicle Specialists at a price not to exceed \$215,000.00 (two hundred and fifteen thousand dollars and zero cents).
2. This resolution is subject to the filing of a certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
