RESOLUTION NO. 22-0203

**AUTHORIZATION TO EXECUTE A CONTRACT WITH DETCON CORP FOR THE PURCHASE OF TWO (2) AUTOMATED BODY GARBAGE TRUCKS THROUGH THE EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY (ESCNJ) AT A PRICE NOT TO EXCEED \$309,431.76**

**WHEREAS**, the Township Committee is desirous of purchasing two (2) Automated Body Garbage Trucks from Detcon Corp through the Educational Services Commission of New Jersey (ESCNJ); and

**WHEREAS**, the two (2) Automated Body Garbage Trucks will be purchased from Detcon Corp. through the Educational Services Commission of New Jersey (ESCNJ) at a price not to exceed \$309,431.76 (three hundred nine thousand four hundred thirty-one dollars and seventy-six cents); and

**WHEREAS**, John Spinapont, Superintendent of Public Works, recommends that the Township Committee purchase two (2) Automated Body Garbage Trucks through cooperative purchasing; and


**WHEREAS**, the Township Administrator concurs with the recommendation to purchase two (2) Automated Body Garbage Trucks through the Educational Services Commission of New Jersey at a price not to exceed \$309,431.76 (three hundred nine thousand four hundred thirty-one dollars and seventy-six cents); and

**WHEREAS**, the Township of Wall entered into the Educational Services Commission of New Jersey on March 12, 2014; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of John Spinapont, Superintendent of Public Works, and authorizes the purchase of two (2) Automated Body Garbage Trucks through the Educational Services Commission of New Jersey State Contract ESCNJ from Detcon Corp at a price not to exceed \$309,431.76 (three hundred nine thousand four hundred thirty-one dollars and seventy-six cents).
2. This resolution is subject to the filing of a certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.


