RESOLUTION NO. 22-0204

AUTHORIZATION TO EXECUTE A CONTRACT WITH HUNTER TRUCK FOR THE PURCHASE OF A 2023 PETERBILT CHASSIS REAR LOADING GARBAGE TRUCK THROUGH SOURCEWELL AT A PRICE NOT TO EXCEED \$158,875.00

WHEREAS, the Township Committee is desirous of purchasing 2023 Peterbilt Chassis Rear Loading Garbage Truck through the Sourcewell cooperative purchasing program; and

WHEREAS, the 2023 Peterbilt Chassis Rear Loading Garbage Truck being purchased are through Sourcewell from Hunter Truck at a price not to exceed \$158,875.00 (one hundred fifty-eight thousand eight hundred seventy-five dollars and zero cents); and

WHEREAS, John Spinapont, Superintendent of Public Works, recommends that the Township Committee purchase the 2023 Peterbilt Chassis Rear Loading Garbage Truck through cooperative purchasing; and


WHEREAS, the Township Committee concurs with the recommendation of the Superintendent of Public Works to purchase the 2023 Peterbilt Chassis Rear Loading Garbage Truck from Hunter Truck through the Sourcewell cooperative purchasing program at a price not to exceed \$158,875.00 (one hundred fifty-eight thousand eight hundred seventy-five dollars and zero cents); and

WHEREAS, the Township of Wall began to participate on July 28, 2016, in the cooperative purchasing program operated by Sourcewell.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Mr. Spinapont, Superintendent of Public Works, to authorize the purchase of a 2023 Peterbilt Chassis Rear Loading Garbage Truck being purchased are through Sourcewell cooperative purchasing program from Hunter Truck at a price not to exceed \$158,875.00 (one hundred fifty-eight thousand eight hundred seventy-five dollars and zero cents).
2. This resolution is subject to the filing of a certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
