RESOLUTION NO. 22-0207

AUTHORIZATION TO EXECUTE A CONTRACT WITH EAGLE EQUIPMENT CORP. FOR THE PURCHASE OF A 34 CUBIC YARD COMPACTOR THROUGH SOURCEWELL AT A PRICE NOT TO EXCEED \$34,985.19

WHEREAS, the Township Committee is desirous of purchasing 34-Cubic Yard Compactor through the Sourcewell cooperative purchasing program; and

WHEREAS, the 34-Cubic Yard Compactor being purchased is through Sourcewell from Eagle Equipment Corp. at a price not to exceed \$34,985.19 (thirty-four thousand nine hundred eighty-five dollars and nineteen cents) and

WHEREAS, John Spinapont, Superintendent of Public Works, recommends that the Township Committee purchase the 34-Cubic Yard Compactor through cooperative purchasing; and


WHEREAS, the Township Committee concurs with the recommendation of the Superintendent of Public Works to purchase the 34-Cubic Yard Compactor from Eagle Equipment Corp. through Sourcewell at a price not to exceed \$34,985.19 (thirty-four thousand nine hundred eighty-five dollars and nineteen cents) and

WHEREAS, the Township of Wall began to participate on July 28, 2016, in the cooperative purchasing program operated by Sourcewell.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Mr. Spinapont, Superintendent of Public Works, to authorize the purchase of 34-Cubic Yard Compactor being purchased are through the Sourcewell cooperative purchase program from Eagle Equipment Corp. at a price not to exceed \$34,985.19 (thirty-four thousand nine hundred eighty-five dollars and nineteen cents).
2. This resolution is subject to the filing of a certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.


