AUTHORIZATION TO EXECUTE A LETTER OF CONSENT WITH DISH WIRELESS RELATED TO THE PROPOSED INSTALLATION 5G ANTENNA(S) AT THE 120' LEVEL OF THE EXISTING TOWER

WHEREAS, Dish Wireless has requested municipal consent to install 5G antenna(s) at the 120' level of the existing cell tower located on Block 272, Lot 1 of Township Property; and,

WHEREAS, Dish Wireless filed a Zoning Permit Application with the Township Land Use Department related to the proposed installation of the 5G antenna(s); and,

WHEREAS, the Land Use Department has reviewed Dish Wireless's Zoning Permit Application and determined that the aforementioned Application meets all zoning requirements and that Dish Wireless maintains all necessary insurance to begin work on Township Property; and,

WHEREAS, prior to the commencement of work, the Township must execute a Letter of Consent acknowledging the proposed work on Township Property and to authorize Dish Wireless to make the proposed alterations on the existing cell tower; and,

WHEREAS, based on the recommendations of the Land Use Department, it is in the best interests of the Township of Wall and its citizens to grant consent to Dish Wireless and the Township has no reason to deny consent; and,

WHEREAS, the consent granted herein is for Dish Wireless to commence work to install 5G antenna(s) on the existing cell tower currently located on Township Property in accordance with the Zoning Permit Application received and approved by the Township Land Use Department.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Township Committee of the Township of Wall, County of Monmouth, State of New Jersey, that the Township of Wall is hereby authorized to execute a Letter of Consent with Dish Wireless; and,

BE IT FURTHER RESOLVED, that all Township officials including, but not limited to the Mayor, Township Administrator, Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to execute the Letter of Consent attached hereto and to effectuate the provisions of this resolution.
