RESOLUTION NO. 22-0525

AUTHORIZATION TO AWARD A CONTRACT TO BLACK ROCK ENTERPRISES FOR IMPROVEMENTS TO OAKWOOD ROAD AND WATER STREET IN THE AMOUNT OF \$265,000.00

WHEREAS, pursuant to N.J.S.A. 40A:11-5 et seq., the Local Public Contract Law, the Township Committee previously authorized the advertisement for the receipt of bids for the improvements to Oakwood Road and Water Street; and,

WHEREAS, on May 5, 2022, the Township received seven (7) bid proposal, which are identified as follows:

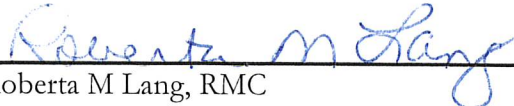

WHEREAS, the Township Attorney reviewed the bid of Black Rock Enterprises and found said bid to be legally sufficient; and,

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendation of Matthew Zahorsky, the Township Engineer, and hereby awards the contract for improvements to Oakwood Road and Water Street to Black Rock Enterprises in the amount of \$265,000.00 (two hundred sixty-five thousand dollars and zero cents).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C. 5:30-5.3(a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
