**AN ORDINANCE TO FIX THE COMPENSATION OF OFFICERS AND EMPLOYEES OF THE
TOWNSHIP OF WALL**

**BE IT ORDAINED BY THE TOWNSHIP OF WALL IN THE COUNTY OF MONMOUTH AND
THE STATE OF NEW JERSEY AS FOLLOWS:**
