

TOWNSHIP OF WALL

ORDINANCE NO. 9 - 2001
AS AMENDED

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, FURTHER AMENDING THE ZONING MAP OF THE TOWNSHIP OF WALL ADOPTED ON JULY 12, 2000.

WHEREAS, the Township Committee on July 12, 2000, adopted an official Zoning Map of the Township; and

WHEREAS, the Township Committee finds that based on recommendations of the Planning Board, Township Planner and consulting planner, and the Township Committee's further consideration of the aforesaid Zoning Map, certain amendments should be made to the Zoning Map of the Township dated July 12, 2000;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

Section 1. The official Zoning Map of the Township of Wall dated July 12, 2000, be and the same is hereby amended to change the zoning designations of the following lots and blocks as indicated:

Section 2. All ordinances, or parts thereof, inconsistent with the provisions of this ordinance be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall effect upon its passage and publication according to law, and upon filing of a certified copy thereof with the Monmouth County Planning Board.

NOTICE

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on March 14, 2001, and was amended by the Township Committee on April 11, 2001. The Ordinance was further amended on July 18, 2001. The Ordinance, as amended, will be further be considered for final passage and adoption at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey on August 8, 2001, at 8:00 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda, at

which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall, Town Hall, to members of the general public who shall request the same.
