

## TOWNSHIP OF WALL

## ORDINANCE NO. 13 - 2001

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 7 "TRAFFIC" OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL 1977 AS AMENDED AND SUPPLEMENTED SECTION 7-3.5 "STOPPING OR STANDING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS".

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Wall, County of Monmouth and State of New Jersey, as follows:

**Section 1.** Chapter 7 "Traffic" of the Revised General Ordinances of the Township of Wall 1977 as amended and supplemented Section 7-3.5, Schedule III entitled "No Stopping or Standing" is hereby amended and supplemented to provide for the addition of the following:

<u>Name of Street</u>	<u>Location and Sides</u>	<u>Hours</u>
Old Bridge Road	From the west side from the Wall Twp./Brielle Borough boundary to State Hwy. 70	All hours
Megill Road	Both sides from Belmar Boulevard to State Hwy. 34	All hours
Wycoff Road/Shafto Road	Both sides from State Hwy. 34 to the Wall Twp./Tinton Falls boundary	All hours
Eighth Avenue	West side from Sea Girt Avenue to Route 71	All hours
Eighteenth Avenue	Entire length within the Wall Township boundary	All hours

**Section 2.** All Ordinances or parts thereof inconsistent with the provision of this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

**Section 3.** Should any section, paragraph, clause of any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not effect or impair the remainder of this Ordinance.

**Section 4.** This Ordinance shall take effect upon its passage and publication according to law and upon submission of a certified copy of the same to the Commissioner of Transportation and to the Monmouth County Traffic Engineer, Carol C. Melnick for approval.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on April 11, 2001, and further be considered for final passage and adopted at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey on May 9, 2001, at 8:00 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall, Town Hall, to members of the general public who shall request the same.
