

**TOWNSHIP OF WALL****ORDINANCE NO. 19 - 1999**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING SECTION 6-3.4 OF CHAPTER VI (ALCOHOLIC BEVERAGE CONTROL) OF THE "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977, AS AMENDED AND SUPPLEMENTED"; PROVIDING FOR AN ADDITIONAL PLENARY RETAIL DISTRIBUTION LIQUOR LICENSE IN THE TOWNSHIP.**

**WHEREAS**, at the present time, there is one (1) plenary retail distribution license authorized and issued in the Township of Wall; and

**WHEREAS**, under New Jersey State Law, the Township is entitled to issue an additional plenary retail distribution license in the Township; and

**WHEREAS**, the maximum annual fee for such a license pursuant to state law is \$2,000.00; and

**WHEREAS**, the plenary retail distribution licenses can be used only for the sale of alcoholic beverages in original containers for consumption off the licensed premises and the issuance of an additional distribution license will not result in the creation of an additional bar or other location for the public consumption of alcoholic beverages;

**WHEREAS**, should the within Ordinance be adopted, the new license to be issued by the Township will be offered for public sale to the highest qualified bidder, pursuant to State law;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

Section I. Chapter VI, "Alcoholic Beverage Control", Section 6-3.4

"License Fees; Maximum Number", of "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, be in the same is hereby further amended and supplemented to read in full, as follows:

"6-3.4 License Fees; Maximum Number. The annual fee and maximum number of licenses for the sale and distribution of alcoholic beverages in the Township will be as follows:

Section 2. Upon the adoption of this ordinance, the additional license created hereby shall be offered at public sale to the highest qualified bidder pursuant to state law and pursuant to specifications and requirements approved by Resolution of the Township Committee.

Section 3. All ordinances, or parts thereof, inconsistent with the provisions of this ordinance be and the same are hereby repealed to the extent of such inconsistency.

Section 4. Should any section, paragraph, clause, or any other portion of this ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this ordinance.

Section 5. This Ordinance shall become effective immediately upon its passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on July 14, 1999 and will be further considered for final passage and adoption at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on August 11, 1999 at 8:00 p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall, Town Hall, to the members of the general public who shall request the same.
