

**TOWNSHIP OF WALL**

**ORDINANCE NO. 30 - 1998**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SCHEDULE VIII (STOP INTERSECTIONS) OF SECTION 7-6.2, "STOP INTERSECTION," OF CHAPTER 7 (TRAFFIC) OF "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977, AS AMENDED AND SUPPLEMENTED."**

**WHEREAS**, the Township Committee now wishes to amend and supplement Schedule VII in order to effectuate the designations of these new Through Streets; and

**WHEREAS**, Section 7-6.2 entitled "Stop Intersections," of Chapter VII (Traffic) of "The Revised General Ordinances of the Township of Wall, 1977," as amended and supplemented, provides in pertinent part that:

Pursuant to the provisions of R.S. 39:4-140, at intersections described in Schedule VIII attached to and made part of this Chapter hereby designated as "STOP Intersections"; and

**WHEREAS**, after a field investigation in an on-site review, it has been determined by the Police Department and the New Jersey Department of Transportation, Bureau of Traffic Engineering Safety Programs that there are several intersections in the Township that should be designated as "STOP Intersections" with appropriate STOP signs to be erected on the near right side of each street, in accordance with the provisions in Section 7.6-2; and

**WHEREAS**, the Township Committee now wishes to amend and supplement is Schedule VIII in order to effectuate the designation of these new STOP intersections;

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the

Township of Wall, in the County of Monmouth, State of New Jersey, as follows:

Section 1. Schedule VIII, "Stop Intersections" of Section 7.6-2, "Stop Intersection," of Chapter VII (Traffic) of "The Revised General Ordinances of the Township of Wall, 1977," as amended and supplemented, is hereby amended and supplemented in order to designate the following intersections as STOP intersections, within the township with appropriate STOP signs to be erected on the near right side of each street, in accordance with R.S. 39:4-140:

<u>INTERSECTION</u>	<u>STOP SIGN ON</u>
Anne Terrace and Maxwell Drive northerly approach and southerly approach	Maxwell Drive, northerly approach and southerly approach
Maxwell Drive and Scott Road	Scott Road
Bailey Road and Anne Terrace	Anne Terrace

Section 2. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall effect upon its passage and publication according to law, but not before approval of the same by the Commission of the New Jersey Department of Transportation.

Notice is hereby given that the foregoing Ordinance was introduced and passed

on first reading by the Township Committee of the Township of Wall on October 14, 1998, and further be considered for final passage and adopted at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey on November 10, 1998, at 8:00 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall, Town Hall, to members of the general public who shall request the same.
