## TOWNSHIP OF WALL

## **ORDINANCE NO.** 15 - 1998

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SCHEDULE XVI, (SPEED LIMITS) OF SECTION 7-11, "SPEED LIMITS," CHAPTER VII, "TRAFFIC" OF "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1997" AS AMENDED AND SUPPLEMENTED.

WHEREAS, Section 7-11, entitled "Speed Limits", of Chapter VII "Traffic" of "The Revised General Ordinances of the Township of Wall, 1997", as amended and supplemented, provides in pertinent part that:

"[T]he streets or parts of streets described in Schedule XVI attached to and made a part of this Chapter shall have the speed limits designated as such schedule for both directions of traffic"; and

WHEREAS, after a field investigation and on-site review, it has been determined by the Police Department and the New Jersey Department of Transportation, Bureau of Traffic and Engineering Safety Programs, that because Wall Church Road has previously been an unposted roadway, a 40- MPH speed limit is recommended for the entire length of the referenced roadway, between Route NJ 35 and New Bedford Road, in accordance with provisions of the section 7-11; and

WHEREAS, the Township Committee now wishes to amend and supplement Schedule XVI in order to effectuate the designation of the 40 MPH speed limit along Wall Church Road;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Wall, in the County of Monmouth, State of New Jersey, as follows:

Section I. Schedule XVI, "Speed Limits," of Section 7-11 "Speed Limits", of Chapter VII "Traffic", of "The Revised General Ordinances of the Township of Wall, 1977," as amended and supplemented, is hereby further amended and supplemented in order to designate the following speed limit for the entire length of Wall Church Road between Route NJ 35 and New Bedford Road, with appropriate speed limits signs to be erected on both sides of the referenced roadway:

A. "Wall Church Road: 40-MPH entire length."

<u>Section II.</u> All ordinances, or parts thereof and consistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

Section III. Should any section, paragraph, clause, or any other portion of this Ordinance by judged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section IV. This Ordinance will take effect upon its passage and publication according to law, but not before approval of the same by the Commissioner of New Jersey Department of Transportation.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on May 12, 1998, and will further be considered for final passage and adopted at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on June 10, 1998, at 8:00 o'clock p.m. or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall, Town Hall, to the members of the general public who shall request the same.
