

**TOWNSHIP OF WALL**  
**ORDINANCE NO. 17 - 1998**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SCHEDULE XVI (SPEED LIMITS) OF SECTION 7-11, "SPEED LIMITS," CHAPTER VII, "TRAFFIC" OF "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1997" AS AMENDED AND SUPPLEMENTED.**

**WHEREAS**, Section 7-11 entitled, "Speed Limits" of Chapter VII, "Traffic" of "The Revised General Ordinances of the Township of Wall, 1997" as amended and supplemented, provides in pertinent part that:

"[T]he streets or parts of streets described in Schedule XVI attached to and made a part of this Chapter shall have the speed limits designated as such schedule for both directions of traffic"; and

**WHEREAS**, after a field investigation and on-site review, it has been determined by the Police Department and the New Jersey Department of Transportation, Bureau of Traffic and Engineering Safety Programs, that the present posted speed limit of 35 MPH along River Road shall be reduced to 25 MPH from Old Bridge Road in a northerly direction to the terminus of River Road; and

**WHEREAS**, it has also been determined, that the present posted speed limit of 35 MPH along Seventeenth Avenue should be reduced to 25 MPH between Route 35 and Route 71, and between Route 71 and the Township of Wall - Borough of South Belmar boundary line in accordance with the provisions of Section 7-11; and

**WHEREAS**, the Township Committee now wishes to amend and supplement Schedule XVI in order to effectuate the designation of the 25 MPH along River Road and the 25 MPH along Seventeenth Avenue.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Wall, in the County of Monmouth, State of New Jersey, as follows:

Section 1. Schedule XVI, "Speed Limits" of Section 7-11, "Speed Limits" of Chapter VII, "Traffic" of "The Revised General Ordinances of the Township of Wall, 1977" as amended and supplemented, is hereby further amended and supplemented in order to designate the following speed limit for River Road from Old Bridge Road in a northerly direction to the terminus of River Road, and for Seventeenth Avenue between Route 35 and Route 71, as well as between Route 71 and the Township of Wall - Borough of South Belmar boundary line, with appropriate speed limit signs to be erected on both sides of the referenced roadway:

- A. "River Road:  
25-MPH from Old Bridge Road in a northerly direction to the terminus of River Road"
- B. "Seventeenth Avenue:  
25-MPH between Route 35 and Route 71, as well as between Route 71 and the Township of Wall - Borough of South Belmar corporate line"

Section 2. All ordinances, or parts thereof and consistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause, or any other portion of this Ordinance be judged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance will take effect upon its passage and publication according to law, but not before approval of the same by the Commissioner of New Jersey Department of Transportation.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on June 10, 1998, and will further be considered for final passage and adopted at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on July 8, 1998, at 8:00 o'clock p.m. or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall, Town Hall, to the members of the general public who shall request the same.
