RESOLUTION NO. 22-0711

**AUTHORIZATION TO EXERCISE A CONTRACT EXTENSION WITH ACTION UNIFORM CO LLC TO PROVIDE POLICE UNIFORMS FOR THE PERIOD JULY 1, 2022 THROUGH JUNE 30, 2023 IN AN AMOUNT NOT TO EXCEED \$68,101.50 NUNC PRO TUNC**

**WHEREAS**, pursuant to the N.J.S.A. 40A:11-1 et seq., the Local Public Contract Law, the Township of Wall (“Township”) advertised for bidders to submit proposals for a contract to provide uniforms for the Police Department for the Township; and,

**WHEREAS**, on July 22, 2020, through Resolution 20-0713, the Township awarded a contract to Action Uniform Co., LLC (“Action Uniform”) to provide uniforms for the Police Department for the Township; and,

**WHEREAS**, on July 26, 2020 the Township of Wall and Action Uniform executed a Contract for Action Uniform to provide uniforms to Wall Township Police Department from the period beginning July 1, 2020 and ending June 30, 2023; and,


**WHEREAS**, pursuant to the Contract dated July 26, 2020, the Township has the unilateral authority to extend the Contract for an additional one (1) year period at the existing contract price; and,

**WHEREAS**, the Police Chief recommends that the Township extend the Contract with Action Uniform for an additional one (1) year period beginning on July 1, 2022 and expiring June 30, 2023 at a price not to exceed \$68,101.50 (sixty-eight thousand one hundred and one dollars and fifty cents).

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby authorizes the Township *nunc pro tunc* to exercise its renewal option pursuant to the July 26, 2020 Contract with Action Uniform Co., LLC to provide uniforms for the Wall Township Police Department from the period beginning July 1, 2022 and ending June 30, 2023 at an amount not to exceed \$68,101.50 (sixty-eight thousand one hundred and one dollars and fifty cents).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C. 5:30-5.3 (a).
3. The Mayor, Municipal Clerk, and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
