**TOWNSHIP OF WALL
ORDINANCE NO. 21-1997**

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL ESTABLISHING THE NAME OF A CERTAIN STREET.

WHEREAS, the residents of a cul-de-sac located off of Allenwood Road near its intersection with State Highway No. 138 and contiguous to Lots 1, 2 and 3 in Block 800 on the Tax Assessment Map of the Township have petitioned the Township Committee to name the cul-de-sac; and

WHEREAS, the Township Committee finds that establishing a name for the aforesaid cul-de-sac is in the best interests of the Township and of the residents thereof; and

WHEREAS, pursuant to N.J.S.A. 40:67-1, the Township Committee is empowered to adopt an ordinance establishing or changing names of streets within the Township;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall in the County of Monmouth, the State of New Jersey as follows:

Section 1. That certain cul-de-sac located off of Allenwood Road and immediately south of the entrance ramp from Allenwood Road to State Highway No. 138, and contiguous to Lots 1, 2 and 3 in Block 800 as shown on the Tax Assessment Map of the Township be and the same is hereby named "Patricia Lane".

Section 2. All Ordinances, or parts thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or any other portion of this

Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 4. The Township Clerk, upon the final adoption and publication of this Ordinance, be and is hereby authorized and directed to forward certified copies thereof to the Monmouth County Clerk for recording; the Chief of Police; the Superintendent of Public Works; the Tax Assessor; the Township Engineer; and all of the department heads of the Township; as well as the record owners of Lots 1, 2 and 3 in Block 800 as shown on the Tax Assessment Map of the Township.


Section 5. This Ordinance shall take effect immediately after final passage and publication as provided by law.
